On the recommendation of Bihar State University Service Commission, Patna under the provisions contained in the Statutes (duly approved by the Chancellor of the Universities of Bihar vide notification memo no.BSU.25/2014-1472/GS(I) dated:10/08/2020 for appointment of Assistant Professors in the Universities of Bihar and communicated to the Patna University by Higher Education, Education Department, Government of Bihar vide its letter no-15/ 2-10/2024-4878 dated:03/12/2024, the following candidates, on the approval of the Syndicate dated 16.04.2025 are appointed as Assistant Professor against the vacant post in the subject of **Geography (Faculty of Social Sciences)** under Patna University Service, Patna on temporary basis in the pay scale of Rs.57700/- to Rs.182400/- (Academic Pay Level-10) with all admissible allowances as per rules of Patna University w.e.f. the date, they join their duties. During the course of their employment in Patna University if any of their certificates is found fake/tampered at any stage, their appointments are liable to be cancelled.

The above selected candidates will be governed by New Pension Scheme and have to abide by the provisions of Service Statute of the Patna University, Patna. No T.A./D.A. shall be paid for joining the post.

As per direction of the Higher Education, Education Department, Government of Bihar received vide aforesaid letter, it is pertinent to mention that the result of successful candidates named above will be affected by the final order judgments of the cases filed in the Hon'ble Patna High Court in this regard. The Selected Candidates have to submit a declaration from 1st Class Judicial Magistrate in the format at the time of joining which is attached with the notification.
