- **Typography:** Times New Roman, Font Size 14 for Heading & 12 for Content.
- **Line Spacing:** 1.5 throughout the document.
- **Word Limit:** 3,000 to 5,000 words (including footnotes).
- **Citation Style:** Strictly follow the Indian Law Institute (ILI) formatting standards.

Submission Protocol

- **Mode of Submission:** Soft copies must be submitted in Microsoft Word format (.doc/.docx).

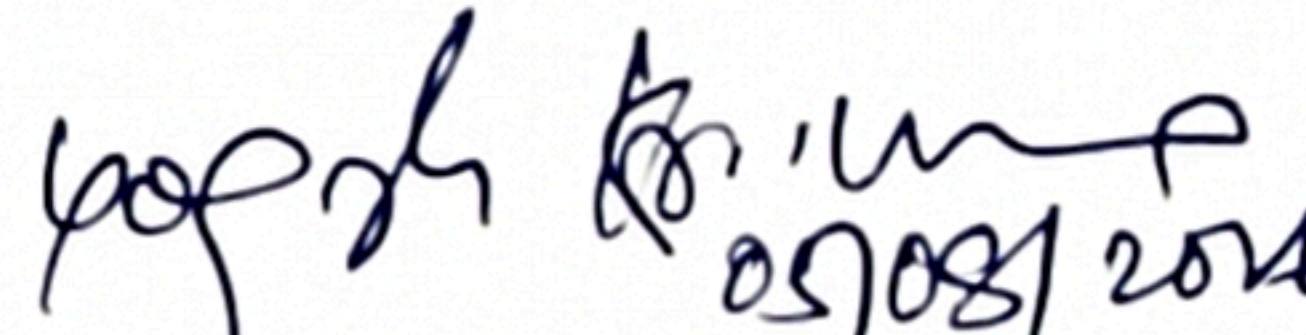
